Required Documents: Blasting Application

All files must be in .pdf format and a maximum size of 16 MB. Each requirement below is to be uploaded as a separate file in order to decrease review time.

- 1. Copy of a valid Explosive Users Certificate
- 2. Copy of a certificate of insurance providing General Liability insurance with limits of not less than \$1,000,000/\$1,000,000
- 3. Copy of a Blasting Bond with the City of Boston or the Commonwealth of Massachusetts named as the certificate holder.
- 4. Copy of Certificate of Competency (Blaster's License) for each person(s) who could be responsible for blasting operations including shot design, charge loading, wiring, and detonation.
- 5. Written proof that Dig Safe has been notified of the proposed blasting operations and a dig safe number was issued.
- 6. Copy of completed Preblast Inspection Surveys
- 7. The route that the explosives are going to be transported to the site. The time of arrival at the site and the time leaving the site should be included.

- 10. General Site Plan showing the temporary storage of explosive materials
- 11. Spec Sheets for the approved day boxes or DOT approved truck mounted magazines

Required Documents: Use of Candles in a Place of Assembly Application

All files must be in .pdf format and a maximum size of 16 MB. Each requirement below is to be uploaded as a separate file in order to decrease review time.

- 1. **Candle Assembly:** A detailed written description of the entire candle assembly, including dimensions, must be provided for each design. Each item listed in the candle assembly must be described in detail with dimensions provided. (Example: Candle assembly #1 consists of a 4-inch tall by 5-inch diameter fishbowl shaped clear glass votive filled with a 2-inch tall by 2-inch wide brown square votive housing a 1-inch tall by 1-inch (1 ounce wax candle).
