## DEPARTMENT OF PUBLIC UTILITIES NOTICE OF FILING, PUBLIC HEARING AND PROCEDURAL CONFERENCE

Petition of Boston Gas Company and Colonial Gas Company, each d/b/a National Grid, for approval of their 20162018 Energy Efficiency ThreeYear Term Report.

On August 1, 2019, Boston Gas Company and Colonial Gas Company, each d/b/a National Grid ("Companies"), filed with the Department of Public Utilities ("Department") their 20162018 ThreeYear Energy Efficiency Term Report ("Term Report"). The filing documents actual energy savings, benefits, and expenditures resulting from the implementation of the Companies' 20162018 threeyear energy efficiency plan approved by the Department in <u>Boston Gas Company and Colonial Gas Company</u>, D.P.U. 15161 (2016). The Department has docketed this matter as D.P.U. 19-94.

The Department will review the Term Report to determine, among other things, whether the Companies: (1) reported their program savings, benefits, and costs accurately and reliably; and (2) implemented their energy efficiency programs in a manner that was consistent with statutory requirements and the Departmentapproved threeyear plan. See G.L. c. 25, § 19(d)(2); G.L. c. 25, § 21(b)(3); G.L. c. 25, §§ 19(a) and (c). Based on the results of the investigation, the Department will approve final recovery of costs incurred during the threeyear term, including performance incentive payments. G.L. c. 25, § 19.

The Department will conduct a public hearing to receive comments on the Companies' filing. The hearing will take place on **Wednesday**, **October 30**, **2019**, **at 2:00 p.m.** at the Department's offices, One South Station, 5<sup>th</sup> Floor, Boston, Massachusetts 02110. A procedural conference will immediately follow the public hearing. Any person who desires to comment may do so at the time and place noted above or submit written comments to the Department not later than the close of business (5:00 p.m.) on **October 30**, **2019**.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department no later than the close of business on **October 21, 2019**. A petition for leave to intervene must satisfy

the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on **October 28, 2019**.

An original hard copy and one copy of all written comments or petitions to intervene must be filed with Mark D. Marini, Secretary, Department of Public Utilities, One South Station, 5<sup>th</sup> Floor, Boston, Massachusetts 02110. One copy of all written comments or petitions to intervene should also be sent to the Companies' attorney, Stacey M. Donnelly, Esq., National Grid, 40 Sylvan Road, Waltham, Massachusetts 02451, and by email, <u>Stacey.Donnelly@nationalgrid.com</u>.

All written comments or petitions to intervene should also be submitted to the Department in electronic format using one of the following methods: (1) by email attachment to <u>dpu.efiling@mass.gov</u> and to the Hearing Officer, Jessica Ellis, <u>Jessica.Ellis@mass.gov</u>, or (2) on a CDROM or USB drive. The text of the email or CDROM/USB must specify: (1) the docket numbers of the proceeding (D.P.U. 1994); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The electronic filing should also include the name, title, and telephone number of a person to contact in the event of questions about the filing. The electronic file name should identify the document, but should not exceed 50 characters in length. All documents submitted in electronic format will be posted on the Department's website: website at
