 - 21' EXISTING POLE TO BE REPLACED WITH A NEW POLE WITH A MAX HEIGHT OF 25.2'.
 - 25' EXISTING POLE TO BE REPLACED WITH A NEW POLE WITH A MAX HEIGHT OF 30'.
