INSTRUCTIONS FOR A ONE DAY AMENDMENT TO AN EXISTING LICENSE

(Revised 5/2022)

- 1. Please complete this application and attach any necessary supporting documentation (i.e. floor plan for the extension of premises, permit(s) from other agencies when extending to public land, and etc.). If you are requesting an extension of premises, the space must be contiguous or physically touches the existing licensed premise.
- 2. Submit the signed form and supporting documentation the Licensing Board at Licensingboard@boston.gov at least two (2) weeks prior to the event to ensure compliance with the Open Meeting Law to provide the Board ample time to review and vote on this application.
- 3. If the license is granted, prior to the event date, you must pick up the license. On the date of the event, the license must be posted in a clear and conspicuous place at the venue. You are subject to and must follow the laws and rules under M.G.L. Ch. 138. You may be subject to discipline or the denial of any future applications if you fail to comply with the laws and rules.
